Purpose

This field modification corrects a problem with the SCSI cable connectors on the rear of the Kalypso 2-M/E and 4-M/E Main Control Panels. The screwlocks originally installed on the control panels' SCSI connectors are too long and may prevent SCSI cable connectors from securely mating with the corresponding panel connectors. This may in turn result in intermittent problems with the CD-ROM, Zip drive, or other devices in the SCSI chain. This field modification requires replacing the two screwlocks installed in the panel SCSI connector with the two new screwlocks provided. This will allow a secure cable connection and preclude any intermittent problems in the SCSI chain associated with an insecure cable connection at the panel.

Instructions

1. Turn off power to the Kalypso control panel by opening the lid and turning off the power supplies.

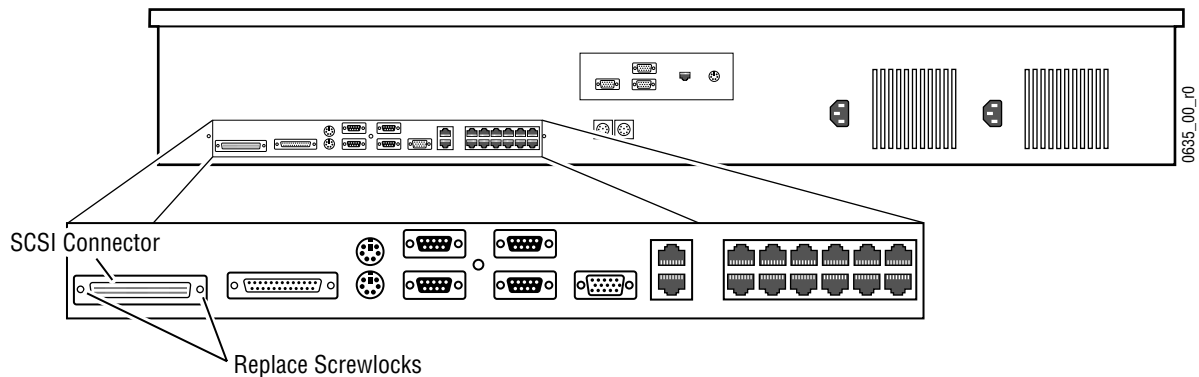
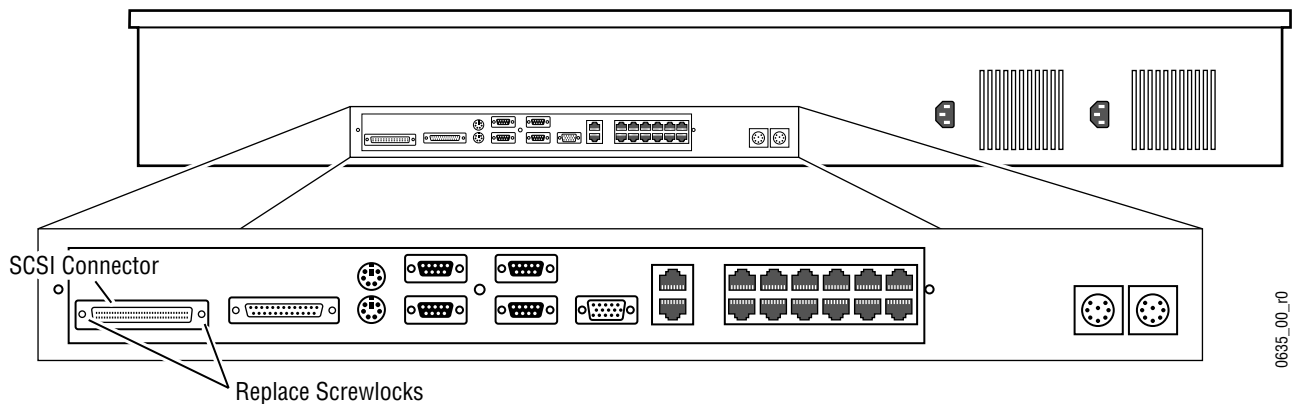


Figure 2. 4-M/E Control Panel SCSI Connector

2. Locate the SCSI connector on the rear of the 2-M/E panel ([Figure 1](#)) or 4-M/E panel ([Figure 2](#)).

3. Remove the SCSI cable by loosening the jackscrews holding it in place.
 4. Examine the screwlocks installed in the connector to determine if they are flush with the end of the connector. If the screwlocks extend beyond the end of the connector, the new screwlocks provided with this kit should be installed.
 5. Remove the existing screwlocks with a nut driver and install the new ones provided.
- Note** The screwlock kits provided include other hardware that is not necessary for this modification. Install just the new female screwlocks and discard the nut and washer included.
6. Make sure the new screwlocks are flush with the SCSI connector and reinstall the SCSI cable. Verify that the cable connection is secure.
 7. Turn power back on to the control panel.

Figure 1. 2-M/E Control Panel SCSI Connector
