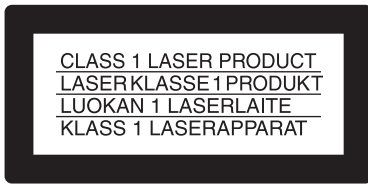

# Overview

The HD Digital Triax CCU Adaptor HAFX200 is designed for connecting a camera to a camera control unit and converting the link format between them from optical fiber to Triax.

The HAFX200 can be connected by optical fiber and Triax, and switched remotely between them for the useful function of Outdoor Broadcasting.

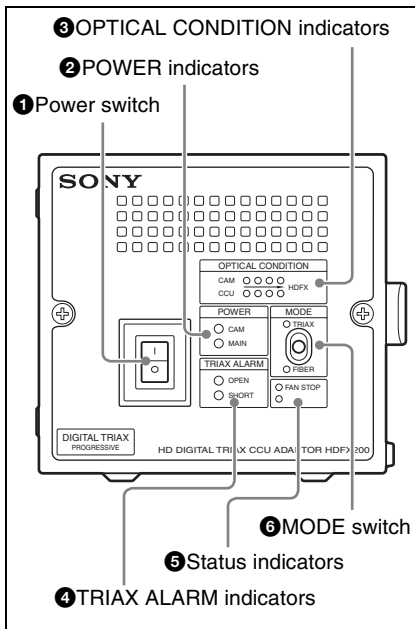
## Rack mount capable

The HAFX200 can be installed in a standard EIA 19-inch rack (up to three units in 3U space).

# Locations and Functions of Parts

## Front panel



### 1 Power switch

This switch controls power to the entire system including the HAFX200, camera, etc. In the “I” position, power is on. In the “O” position, power is off.

### 2 POWER indicators

When power is on, the MAIN indicator and CAM indicator light up. When the CAM POWER switch on the Master Setup Unit or the Remote Control Panel is pressed, only the camera power is turned off and the CAM indicator goes out.



### ③ OPTICAL CONDITION indicators

Displays the optical signal receiving condition of the HDFX200 from a camera or Camera Control Unit.

- Two green indicators light up (3rd and 4th indicators): Reception is very good.
- One green indicator lights up (3rd indicator): Reception is good.
- The yellow indicator lights up (2nd indicator): Reception is poor.
- The red indicator lights up (1st indicator): Reception is very poor.

### ④ TRIAX ALARM indicators

#### OPEN (red):

Lights up when a camera is not connected via the Triax cable.

#### SHORT (red):

Lights up when one of the power supply lines of the Triax cable is shorted to the outer shield, or when there is a short between the power supply lines. While the indicator is lit, the camera is not powered.

### ⑤ Status indicators

#### FAN STOP (red):

Lights up when the ventilator fan has stopped.

### ⑥ MODE switch

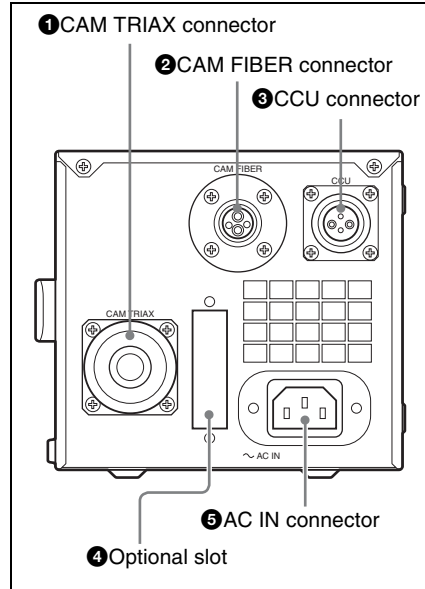
#### TRIAX:

The TRIAX indicator lights up in green. The HDFX200 powers a camera that is connected to the CAM TRIAX connector, and transmits/receives signals between the HDFX200 and the camera with the TRIAX cable.

#### FIBER:

The FIBER indicator lights up in green. The camera control unit powers a camera that is connected to the CAM FIBER connector of the HDFX200, and transmits/receives signals between the HDFX200 and the camera with the optical fiber cable.

## Rear panel



### ① CAM TRIAX connector (Triax connector)

This is a Triax cable connector for the link to the HD Digital Triax Camera.

### ② CAM FIBER connector (Optical fiber connector)

This is an optical fiber connector for the link to the HD Color Camera.

### ③ CCU (Camera Control Unit) connector (Optical fiber connector)

This is an optical fiber connector for the link to the Camera Control Unit. Power, control signals, video signals, audio signals etc., can be carried over a single link.

### Note

If there is dust or other contamination on the connection face for the optical fiber cable, transmission errors will occur. Be sure to protect the connector with the supplied cover when not in use.

**④ Optional slot**

For the future expansion.

**⑤ AC IN connector**

Use the supplied power cord to connect this to an AC outlet. The supplied plug holder can be used to fasten the power cord to the unit.

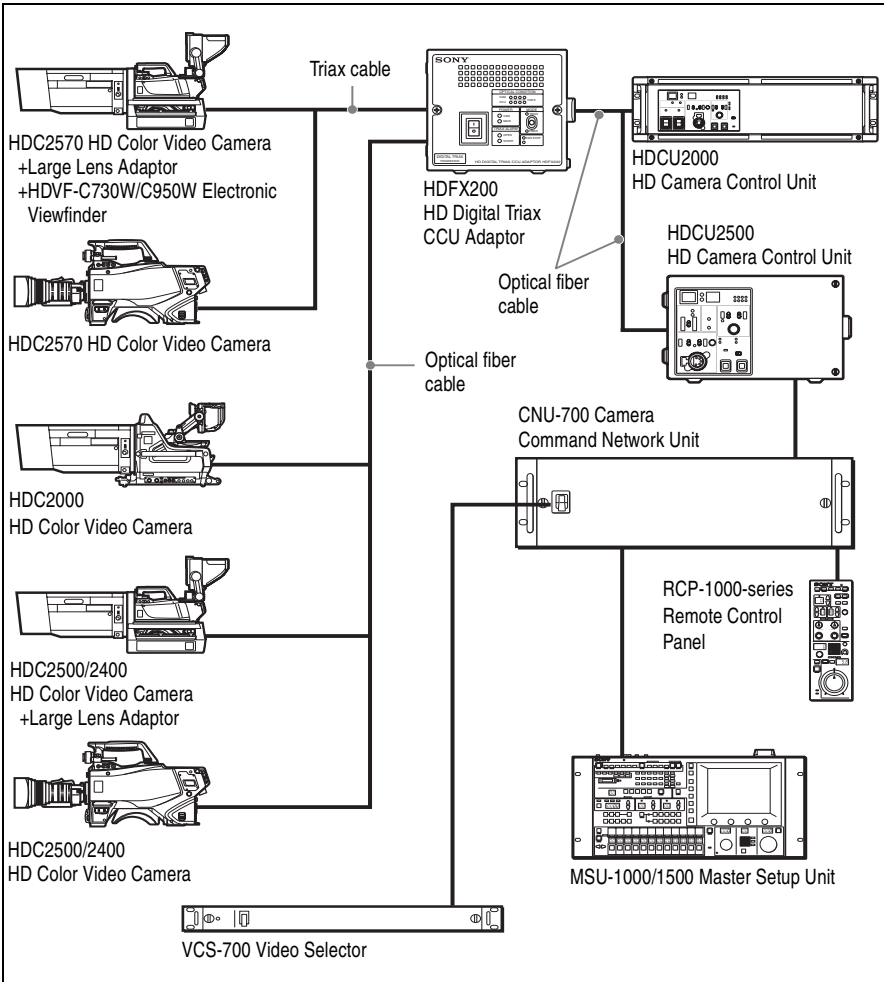

# Usage Precautions

---

## Installation environment

Make sure that the installation environment fulfills the following requirements:

- Dry and well ventilated
- Not subject to high temperatures or close to heat sources
- Not subject to strong electric or magnetic fields
- Not exposed to direct sunlight, strong lamps or similar

---

## To prevent electromagnetic interference from portable communications devices

The use of cellular phones and other communications devices near this camera can result in malfunctions and interference with audio and video signals.

It is recommended that the portable communications devices near this camera be powered off.

---

## Digital Triax Transmission

A powerful error-correction function is incorporated for the transmission between the camera and CCU. However, if an error occurs on long-distance transmission because of external noise or for some other reason, the compensation by interpolation that partially uses the previous picture may operate.

In digital triax transmission, the following video delay in transmission may occur:

- The video delay in transmission between the camera and the CCU is approx. 9 msec to 12 msec.
- A delay of about 1 frame occurs on the viewfinder display if a camera image is sent back from the CCU to the camera as a return signal.
- The prompter video will delay approx. 3 frames. There will be some changes in picture quality and active area, and dropped frames may occur depending on the type of prompter video.
- An appropriate delay is applied to the MIC 1 and 2 audio signals from the CCU according to the video delay.
- It takes a certain time until the video signal transmitted between the camera and the CCU becomes stable after power is applied. This is not a malfunction.

### Triax transmission distances

The maximum and minimum transmission distances allowed for triax cable connection are shown in the table below. The distances may vary according to the conditions, such as the total power requirements (including the power supply to the camera from the HDFX200) and cable degradation. Allowable transmission range when using triax cables with the following characteristics:

Attenuation: 3.8 dB to 53.2 dB at 100 MHz (including the loss at connectors)

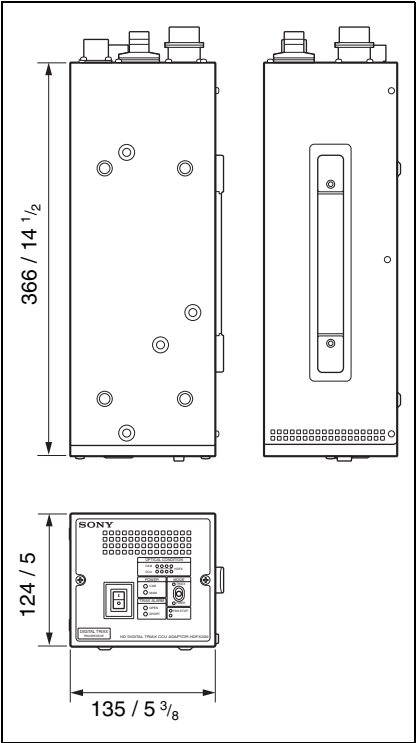

### Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete object files to the recipients, so that they can relink them with the library after making changes to the library and

recompiling it. And you must show them these terms so they know their rights.

We protect your rights with a two-step method: (1) we copyright the library, and (2) we offer you this license, which gives you legal permission to copy, distribute and/or modify the library.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Whether that is true depends on what the Library does and what the program that uses the Library does.

1. You may copy and distribute verbatim copies of the Library's complete source code as you receive it, in any medium, provided that you conspicuously and appropriately publish on each copy an appropriate copyright notice and disclaimer of warranty; keep intact all the notices that refer to this License and to the absence of any warranty; and distribute a copy of this License along with the Library.

You may charge a fee for the physical act of transferring a copy, and you may at your option offer warranty protection in exchange for a fee.

2. You may modify your copy or copies of the Library or any portion of it, thus forming a work based on the Library, and copy and distribute such modifications or work under the terms of Section 1 above, provided that you also meet all of these conditions:
  - a) The modified work must itself be a software library.
  - b) You must cause the files modified to carry prominent notices stating that you changed the files and the date of any change.
  - c) You must cause the whole of the work to be licensed at no charge to all third parties under the terms of this License.
  - d) If a facility in the modified Library refers to a function or a table of data to be supplied by an application program that uses the facility, other than as an argument passed when the facility is invoked, then you must make a good faith effort to ensure that, in the event an application does not supply such function or table, the facility

still operates, and performs whatever part of its purpose remains meaningful.
